Wall Intermediate School SCHOOL-PARENT COMPACT

 - Progress charts for Achieve3000 and Tenmarks
 - Annual PARCC scores
4. Provide parents opportunities to actively engage in their child's learning experience as it relates to our targeted instructional model. Specifically those learning experiences include:
 - Parent meeting – 12/10/14 at 6:30PM
 - Parent access to Achieve 3000 and Tenmarks additional Internet resources
 - Additional resources available to increase opportunities for success

Additional WIS Responsibilities

1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.
2. Hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs.
